"Pursuant to the Ref. No. Ref. No. BSRDCL/PIU 6-Lane G.B./139/2018-174 Date : 12.03.2018 subsequent Tender Notice FN139-2018/17-18/01 for Providing Security Services hoisted on BSRDCL website with prebid meeting date was 19.03.2018.

Firstly, Manager (Tech) welcome all the bidders' representative.

MoM was published in the BSRDCL website to inform the bidders regarding the decision on the bid and it was asked to raise any query within 03 days to PIU 6-Lane Ganga Bridge if they have any grievances. Grievance from the 02 following bidders were received.


1. M/s. Jet Intelligence Security Pvt. Ltd.
2. M/s. Puja Detective & Security Services Pvt. Ltd.

To resolve the grievances, M/s. Jet Intelligence Security Pvt. Ltd., Puja Detective & Security Services Pvt. Ltd. and M/s. Everest Human Resource Consultants were requested on mobile to be present in the PIU 6-Lane office on 04.06.2018 at 11.30 am. The issue was discussed in detail and outcome is as follows:

- It was accepted by the M/s. Jet Intelligence Security Pvt. Ltd. that their quoted rate on unskilled category of worker (Rs.247/- per day) is not as per circular (Rs.257/- per day) . Therefore the rate quoted is not valid.
- Puja Detective & Security Services Pvt. Ltd. complain was investigated in detail and it was observed that the GST is not included in their quoted rate by M/s. Everest Human Resource Consultants. The EPF quoted is 12%, which less than 13.15% also the relieving charges in not as per circular. In view of this, the bid of M/s. Everest Human Resource Consultants is also not valid.
- The rate quoted by Puja Detective & Security Services Pvt. Ltd. is only valid. The bid may be awarded to Puja Detective & Security Services Pvt. Ltd. after negotiation.

The above decision is acceptable to all the bidders present in the meeting.
