Since submission of Principal Employer Certificate in support of construction experience is mandatory as per bid document, so, the construction experience w.r.t contract of similar size and nature has not been considered.
2	M/s BLPL-C&C(JV)	The requirement for availability of financial resources is INR 54.81 Million for one partner and INR 34.26 Million for each partner and INR 137.03 Million for all partners combined for the subject contract. Whereas on evaluation it has been found that the financial resource of the bidder i.e financial resources as calculated in FIN-3 less Current Contract Commitments in FIN-4 is INR (-) 18920.16 Million (less than the requirement for one partner) for M/s C&C and INR 37.25 Million for M/s BLPL and INR (-)18882.91 Million for all partners combined, which is less than the requirement
3	M/s Supreme-SDPL-SECPL(JV)	The requirement for availability of financial resources is INR 54.81 Million for one partner and INR 34.26 Million for each partner and INR 137.03 Million for all partners combined for the subject contract. Whereas on evaluation it has been found that the financial resource of the bidder i.e financial resources as calculated in FIN-3 less Current Contract Commitments in FIN-4 is INR (-) 4570.95 Million (less than the requirement for one partner) for M/s Supreme, INR 15.34 Million (less than the requirement for each partner) for M/s Shristi, INR 119.328 for Sai Engicon and INR (-) 4436.28 Million for all partners combined, which is less than the requirement.
