

Proceedings

"Pursuant to the Ref. No. BSRDCL/PIU 6-Lane G.B./139/2018-174 Date : 12.03.2018 subsequent Tender Notice FN139-2018/17-18/01 for Providing Security Services hoisted on BSRDCL website (Annexure-2) with prebid meeting date was 19.03.2018. Accordingly the prebid reply also displaced in the BSRDCL website. The last date for submission of the bid as 21.03.2018 at 3.00 PM and with opening of bid on the same day at 3.30 PM. Six bids were received and opened on 21.03.2018 at 3.30 PM by the Bid Evaluation Committee in the presence of tenderers/their representatives, who were present. The bid was evaluated as per the criteria mentioned in the bid document and following bidders were qualified for opening of financial bid.

All the successful bidders in the technical bid were informed vide this office letter No. BSRDC Ltd./PIU (6-Lane G.B.) - 139-2018-249 dated 31.03.2018 for the opening of financial bid on 02.04.2018 at 11.00 am at PIU 6-Lane Ganga Bridge Office. Firstly, sealed envelope of financial bid was shown to all representatives of the bidder and signed by them. The financial bid was opened in the presence of bidders/representative. The rate quoted by the firms are as under:


The bid evaluation committee evaluated the price bid in detail and observed that the bidder M/s. Jet Intelligence Security Pvt. Ltd., M/s BISWAS Security Services India (P) Ltd., M/s PSIS Security Management Services Pvt. Ltd. and M/s. Animation Security Services have quoted the wages @ Rs.247/- per day which is lower than the minimum wages of semiskilled categories of workers (Rs.257/-) and is not as per notification issued by Labour Resource Department, Govt. of Bihar dated 15.09.2017. In view of the above, they are not fulfilling the minimum wages criteria and disqualified.


The amount quoted by the qualified bidders M/s Everest Human Resource Consultants and M/s. Puja Detective & Security Services Pvt. Ltd are Rs.6,69,041.04 and Rs.13,16,787.36 respectively. Committee found that M/s Everest Human Resource Consultants is the lowest bidder.

In view of the above, bid evaluation committee recommended to engage the security services at PIU 6-Lane Ganga Bridge for 2 years to lowest bidder i.e. M/s Everest Human Resource Consultants after negotiation.

The Committee also decided that the proceeding should be uploaded on the BSRDCL website to view the bidders of participated in the above said tender. The comment of the bidders on the decision of the evaluation committee awaited for 3 days from the upload on the BSRDCL website.
