All the above successful bidders were informed vide this office letter No. BSRDC Ltd./PIU (6-Lane G.B.) -141-2018-853 dated 29.10.2018 for the opening of financial bid on 31.10.2018 at 11.00 am at PIU 6-Lane Ganga Bridge Office. Firstly, sealed envelope of financial bid was shown to all representatives of the bidder and signed by them. The financial bid was opened in the presence of bidders/representative. The bid evaluation committee evaluated the price bid in detail and observed and comparative statement is as follows:



1. M/s. Roushan Enterprises and M/s. Mahima Enterprises have quoted their rate for Office Boy & Pantry Assistant (Semi Skilled) and Sweeper (Unskilled) vide Labour Resource Department, Govt. of Bihar vide Memo No. 5/MW-402/08-1460 dated 28.03.2018, which is not justifiable for office boy and pantry assistant hence disqualify.
2. M/s. Puja Detective & Security Services Pvt. Ltd. have quoted their rate for Office Boy & Pantry Assistant (Semi Skilled) vide Labour Resource Department, Govt. of Bihar Memo No. 5/MW-403/07-1454 dated 28.03.2018 and for Sweeper (Unskilled) vide Memo No. 5/MW-402/08-1460 dated 28.03.2018 and qualified.
3. M/s. Vidhya Kamakhya Projects Pvt. Ltd. has quoted their rate for Pantry Assistant (Semi Skilled) vide Labour Resource Department, Govt. of Bihar Memo No. 5/MW-403/07-1454 dated 28.03.2018 and for Office Boy (Semi Skilled), Sweeper (Unskilled) vide Memo 5/MW-402/08-1460 dated 28.03.2018 which is not justifiable for office boy hence disqualify.

In view of the above, committee recommends to engage the successful M/s. Puja Detective & Security Services Pvt. Ltd for housekeeping services at PIU 6-Lane Ganga Bridge.

The Committee also decided that the proceeding should be uploaded on the BSRDCL website to view the participated bidders in the said tender for their comment, if any. The comment of the bidders on the decision of the evaluation committee shall be awaited for 3 days from the upload on the BSRDCL website. If no adverse comment is received, the bid shall be awarded as per committee decision.
