Since submission of Principal Employer Certificate in support of construction experience is mandatory as per bid document, so, the construction experience w.r.t contract of similar size and nature has not been considered. (ii) Both the partners have submitted Letter of Technical Bid separately and individually whereas it should be submitted a Letter of Technical Bid as a Joint Venture in the format as provided in the Section-4 of Bid Document.
2	M/s BLPL-C&C(JV)	The requirement for availability of financial resources is INR 63.98 Million for One Partner, INR 39.99 Million for each Partner and INR 159.95 Million for all partners combined for this project whereas; on evaluation it has been found that the financial resources i.e. (FIN-3) – (FIN-4) of the M/s C&C Construction Limited is INR (-ve) 18919.82 Million (less than the requirement for one partner), M/s Broadway Links Pvt. Ltd is INR 57.25 Million and as combined INR (-ve) 18862.57 Million, which is less than the requirement.
