

It states that the staffing levels set out in these TOR are for guidance only, on the contrary it also states that consultants are required to furnish the Bio-data of Key personnel. However, Page 1; Format for submission of EOI does not state any format or requirement of Key personnel Bio-data at EOI Stage. Please Clarify.	The Bio-data of Key personnel are not required at EOI stage, but it is required at RFP stage. This clause is mentioned in TOR which is part of RFP document. It is only for guidelines at EOI stage.
