1. Bihar State Road Development Corporation Limited (BSRDCL), a Government of Bihar Undertaking, the Executing Agency, now extends the invitation of sealed bids from eligible bidders for the Construction and completion of the civil works for Construction of Railway Over Bridge (R.O.B.) with its approaches under the Project with modified details as under, subject to compliance to ADB policies and requirements. This work comprises civil works contract package as under -

3. National Competitive Bidding will be conducted in accordance with ADB's Single Stage: Two-Envelope Bidding Procedure and is open to bidders.
4. Only eligible bidders with the following key qualifications should participate in this bidding
 - Successfully completed single work within the last 5 years with a value of at least **Rs. 238.63** million for AFBSHP-II/1/ROB (SH-83) of similar nature.
 - Minimum average annual construction turnover within the last 3 financial years should be **Rs. 477.26** million for AFBSHP-II/1/83 ROB (SH 83).
 - Key Equipments and persons requirement shall be as per Bid Document assessed for the completion of works.
 - Joint Venture shall be allowed.

No liability will be accepted for loss or late delivery.

7. Bids must be delivered:


